- Teams will not be permitted to play future matches until forfeit fees are paid.
- Teams who forfeit 3 times may be removed from the competition.
- All prices, dates and times are subject to change. Teams will be notified immediately through contact details provided.
- Offensive or inappropriate team names will not be accepted.
- Match times fall between 5pm – 10pm (estimated)
- Ages 12/13s, 14s, 15s, 16s, 17 & Under. – **AGE GROUPS MAY BE COMBINED PENDING COMPETITION NUMBERS.**
